#### Subject of the Disclosure

Omnibus Agreement among AC Energy Corporation, ACE Endevor, Inc, Greencore Power Solutions 3, Inc., and Citicore Solar Energy Corporation

Background/Description of the Disclosure

Further to our disclosure dated 17 December 2020, please be advised that the Company and ACE Endevor, Inc. ("Endevor"), the Company's wholly-owned subsidiary, signed today, 4 February 2020, an Omnibus Agreement ("Agreement") with Greencore Power Solutions 3, Inc. (the "Borrower"), and Citicore Solar Energy Corporation ("CSEC") for the financing of the Borrower's 50MWac (72MWdc) solar power plant project located in Arayat and Mexico, Pampanga, and associated facilities (the "Plant").

Under the Agreement, the Company, as Lender, will be extending a term loan facility to the Borrower in the amount of up to PHP2.675BN to finance the design, engineering, financing, construction, procurement and supply, manufacturing, commissioning, start-up, testing, delivery, ownership, operation and maintenance of the Plant, which is expected to be operational in November 2021. The loan will be secured by (1) a real estate mortgage over the Borrower's real assets in favor of the Company, (2) a mortgage and pledge over the shareholding of the shareholders of the Borrower, and (3) the cashflows of the project.
