Completion of subscription by Arran Investment Pte Ltd ("Arran") to Primary Shares in AC Energy Corporation ("ACEN") pursuant to a private placement

Background/Description of the Disclosure

Further to disclosure report numbers C07906-2020 dated 12 November 2020 and C01525-2021 dated 10 March 2021, this is to announce the completion of the subscription by an affiliate of GIC Private Limited ("GIC"), Arran, to four billion primary shares of ACEN, via a private placement. For purposes of the private placement, ACEN and Arran signed a Subscription Agreement for the issuance of the primary shares to Arran. In addition, ACEN, Arran, and AC Energy and Infrastructure Corporation ("ACEIC") also signed today, a Shareholders' Agreement pursuant to their Investment Agreement dated 30 December 2020.

The private placement is the first tranche of GIC's investment to achieve a 17.5% ownership stake in ACEN ("the Investment"). The Investment will be implemented through a combination of subscription to four billion primary shares via a private placement, and the purchase of secondary shares from ACEIC (the "Top Up"). The Top Up will enable GIC to achieve the target 17.5% percent ownership stake in ACEN, taking into consideration GIC's dilution from the recently announced follow-on offering to be conducted by ACEN, and the planned infusion of ACEIC's international assets into ACEN.
