### Subject of the Disclosure

Issue and Listing of ACEN's Php-denominated ASEAN Green Fixed Rate 5-year Bonds

### Background/Description of the Disclosure

On 22 September 2022, the Company issued and listed on the Philippine Dealing & Exchange Corp. its ASEAN Green fixed-rate bonds with a tenor of five (5) years, in the aggregate principal amount of Ten Billion Pesos (Php10,000,000,000.00) due 2027 and with an interest rate of 6.0526% (the "Green Bonds"). The Green Bonds were issued as the first tranche of the Company's Thirty Billion Peso Securities Program approved by the Securities and Exchange Commission on 8 September 2022.

The Company launched the public offer and sale of the Green Bonds on 9 September 2022, and was concluded on 15 September 2022 at 5:00 p.m.
